- □ Proof of Current WHMIS Instruction/Training

Each application must include:

- A completed Permittee Application form (specify which category you are applying for)
- □ This sheet with your qualifications checked off
- □ A resume which outlines your experience relating to animals (specify the types of animals you have handled and/or trained)
- □ Photocopies of all relevant documents/educational certificates.
- □ A list of any animals and/or equipment you may have
- □ \$ 50 processing fee

If you are accepted as a Permittee, it is your responsibility to keep your Resume up to date as well as your correct address and phone number on file at the Union Office. Any person without current information on file will be removed from the roster.

- □ Proof of Current WHMIS Instruction/Training
- Basic First Aid
- □ Collective Agreement and Health & Welfare Seminar
- □ 2 Letters of recommendation (1 Local 856 Animal Head Wrangler and 1 Production Manager)

Crossover (Inter-Department listing) – the applicant must also possess all of the following:

- **G** 60 days work experience in Animal Wrangling under Local 856 Collective Agreements
- □ Set Etiquette course
- □ Proof of Current WHMIS Instruction/Training
- □ 2 Letters of recommendation (1 Local 856 Animal Head Wrangler and 1 Production Manager)
- □ Collective Agreement and Health & Welfare Seminar (if upgrading into a Key position)
