- Minimum Valid Class 4 Driver's License
- Current Driver's Abstract (a copy must be provided along with Application)
- Basic First Aid
- Collective Agreement course

- Must previously be listed as Transport Captain
- 2 Letters of reference from direct supervisor
- Collective Agreement Seminar

Transport Captain

- 100 Days worked on 3 or more IATSE Productions in that position
- Must previously be listed as a Unit Mover & Crew Driver
- Letters of reference from 2 different Transportation Department Coordinators
- Collective Agreement Seminar

Head Driver

- 60 Days worked on 2 or more IATSE Productions in that position
- Must previously be listed as a Unit Mover & Crew Driver
- Letters of reference from 2 different Transportation Department Coordinators
- Collective Agreement Seminar

Honey Wagon Operator

- 60 Days worked on 2 or more IATSE Productions in that position
- Must previously be listed as a Unit Mover Driver & Crew Driver
- Class 1 Licence with Air Brake
- Letters of reference from 2 different Transportation Department Coordinators

Mechanic
