Thank you for your interest in the Transportation Department of IATSE Local 856. Please take a few moments to read the following before filling out an application.

**MY APPLICATION IS FOR:** Please check off which position within the department you are applying for:

- Driver**  **Unit Move Driver – Class 4**  
 **Unit Move Driver – Class 1**

**If you are applying for any position other than a Unit Move Driver you must provide two Letters of Reference from two different Transportation Department Keys recommending you for the position you are applying for.**

To apply for **Permittee** status in the Transportation Department, an applicant must provide proof of the following:

- A valid Class 4 Licence (minimum)
- Proof of **Set Orientation Course** (Contact Film Training Manitoba at 989-9669 for details)
- Proof of **Intro to Paper** course ( Film Training Manitoba)
- Proof of Current **WHMIS** Instruction/Training (Contact Film Training Manitoba at 989-9669 for details)
- A current driver's abstract
- First Aid (recommended, may become mandatory)

Please note that a **copy of each document must be included with your application.** Please bring your licence and abstract to the office along with your application.

Can you drive:

- An **automatic** transmission
- A **standard** transmission

The applicant must be in good physical condition as there may be heavy lifting involved. The applicant must have extensive driving experience as you may have to operate the following:

- 5 ton trucks – mandatory for Unit Move Drivers
- 15 passenger vans – mandatory for Cast Drivers
- Class A motor homes – Mandatory for Unit Move or Cast Drivers
- Boats
- Snowmobiles
- 1 ton cube vans
- Skyjack/Scissor Lifts
- Towing other vehicles – Mandatory for Unit Move Drivers
- Motorcycles
- Very expensive picture vehicles – mandatory for Unit Move and Cast

Also please check if you have had any electrical training

- Electrical Training

In addition, good people skills are required, as you will be dealing with a wide range of personalities and people.

**Specific Requirements/Minimum Qualifications:**

**Membership** – Applicants for Membership must demonstrate all of the following:

- Minimum of 60 days (4 or 6 hour calls count as a ½ day) working on a minimum of 2 IATSE productions in the department (and in the position) applying for;
- Letters of reference from 2 different Transportation Department Keys/Heads;
- Valid Class 4 Drivers License & Driver’s Abstract (a copy must be provided along with Application);
- Set Orientation course;
- Proof of Current WHMIS Instruction/Training;
- Basic First Aid
- Collective Agreement and Health & Welfare Seminar

**Department Transfer** – Applicants for Department Transfer must demonstrate the following:

- Must be a member in good standing;
- Set Orientation course;
- Proof of Current WHMIS Instruction/Training;
- Valid Class 4 Drivers License & Driver’s Abstract (a copy must be provided along with Application);
- Minimum of 60 days (4 or 6 hour calls count as a ½ day) working on a minimum of 2 IATSE productions in the department (and in the position) applying for;
- Two letters of recommendation from Transportation Keys.

**Members Upgrading** – Members wishing to upgrade their classifications must demonstrate the following:

- Minimum of 60 days (4 or 6 hour calls count as a ½ day) working on a minimum of 2 IATSE productions in the department (and in the position) applying for;
- Valid Class 4 Drivers License & Driver’s Abstract (a copy must be provided along with Application);
- Letters of recommendation from 2 Transportation department Keys/Heads;
- Must be a member in good standing.
- Collective agreement and Health & Welfare Seminar ( required for upgrades to Key position)
